NALA Affiliate Awards

The NALA Affiliate Awards are presented each year to NALA members or committees of affiliated associations, where a majority of the committee members are NALA members, in recognition of their contribution to the goals and programs of an affiliated association. Designees are nominated by their affiliated association for such contributions as assisting with and organizing CP study groups, working with bar associations on behalf of the legal assistants in the area, planning educational programs, and developing a pro bono or other community involvement program for the affiliate. These examples serve only as guidance for the affiliated association - the association may set its own standards for recognition.

The affiliated association may designate one recipient for an affiliate award each year. There is no selection process on the part of NALA for the affiliate award. NALA will recognize these recipients by presenting a framed award to each one during the membership award presentations.

Nomination forms for the Affiliated Associations Awards must be received by May 1. Affiliate award nominees are:

- 1) automatically considered for the National Outstanding Contribution Award
- 2) honored and presented with a special plaque during the Annual Meeting of Affiliated Associations
- 3) honored by a write up in the Annual Awards Program distributed at the NALA Annual Meeting of Members.

Late Filing Period

Nominations for the Affiliated Associations Awards received between May 2 and May 31 will be accepted under limited conditions. These nominees will be honored and presented with a special plaque during the Annual Meeting of Affiliated Associations.

Late nominations will be ineligible for consideration for the annual Outstanding Contribution Award. The possibility of including information about the nominee in the Annual Awards Program will vary with each meeting; there is no guarantee that the late nomination will be included in printed information. Nominations after May 31 will not be accepted.

NALA Affiliated Associations Outstanding Contribution Award

Each recipient of a NALA Affiliate Award is automatically nominated for the Outstanding Contribution Award, the pinnacle award of the NALA Affiliated Associations. The purpose of this award is to recognize exceptional achievement among recipients of the NALA Affiliate Awards. Examples of these achievements include contributions to relationships among the paralegal profession, the public, and the legal community; exceptional leadership within an affiliate including proposing or developing ethical codes or guidelines; and serving as a founder of an affiliated association.

The forms submitted by an association designating recipients of an affiliate award are reviewed by an Affiliated Associations Award Committee appointed by the NALA Board of Directors, and chaired by the Affiliated Associations Director. Members of the committee must have either served as an affiliated associations director or secretary, or as a NALA board member. Former recipients of an Affiliate Award or Outstanding Contribution Award are also eligible to serve on this selection committee. The recipient of the NALA Affiliated Association's Outstanding Contribution Award is advised in early June.

National Affiliated Associations Achievement Award

The National Affiliated Associations Achievement Award is designed to recognize the achievements and contributions of an individual affiliate member, a committee of an affiliated association, or of an affiliated association itself which have a national and long-lasting impact. Examples of these national contributions may include development or participation in a community service program which results in a positive public image for the paralegal profession on a national basis; contributions to paralegal education such as publishing a book; or development of a nationally recognized professional development or career enhancement program.

This special award may or may not be conferred annually. Nomination forms for the National Affiliated Associations Achievement Award are included at the end of this publication. Associations may submit one nomination per year. Candidates are selected by the Affiliated Associations Award Committee, appointed by the NALA Board of Directors, and chaired by the Affiliated Associations Director.

Please note that National Affiliated Associations Achievement Award nomination forms are **only** considered for the National Affiliated Associations Achievement Award. If you wish to ensure an award for your association's nominee, please be sure to submit the Affiliate Award form.

National Affiliated Associations Achievement Award nominations must be received by May 1 each year. Applications received after May 1 will not be accepted.

2018 National Affiliated Associations Achievement Award Nomination Form

Award Description

The National Affiliated Associations Achievement Award is designed to recognize the achievements and contributions of an individual affiliate member, a committee of an affiliated association, or of an affiliated association itself which have a national and long-lasting impact. Examples of these national contributions may include development or participation in a community service program which results in a positive public image for the paralegal profession on a national basis; contributions to paralegal education such as publishing a book; or development of a nationally recognized professional development or career enhancement program.

Requirement for the Award

The person, committee or association nominated must have played a significant part in creating, developing, and/or promoting an important and distinctive program which positively impacts NALA or the legal assistant profession on a nationwide basis for a minimum of three years.

Qualification for Award

Affiliated associations, committees of affiliated associations, and individual members of an affiliated association may qualify for this award.

Nominations for Award

A NALA Affiliated Association may nominate itself, a current or former committee of itself, or one of its current or former active members for this award. It may also nominate another affiliated association, a current or former committee of another affiliated association, or a current or former active member of another affiliated association for the award. The nomination form must be signed by the President and NALA Liaison as sponsors of the nomination. The nominating association must be a NALA affiliated association in good standing. Student associations are not eligible to participate.

Deadlines

The National Affiliated Associations Achievement Award Nomination Form must be received by NALA Headquarters no later than May 1. Applications received after May 1 will not be accepted. Recipients will be notified by June 1.
